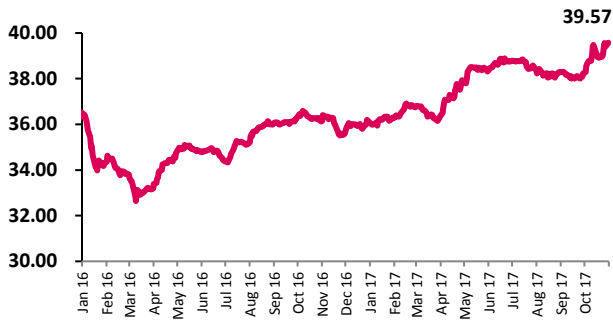

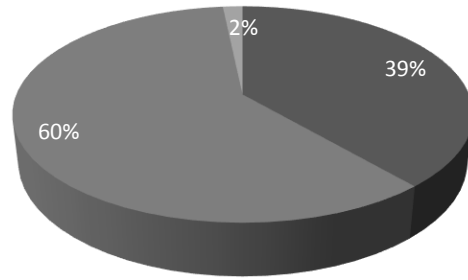
Your fund performance: Growth fund

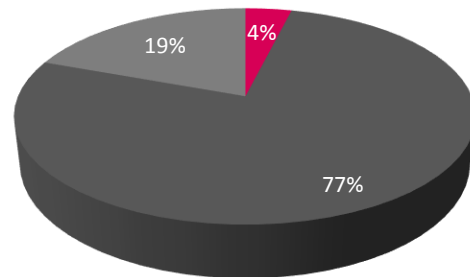

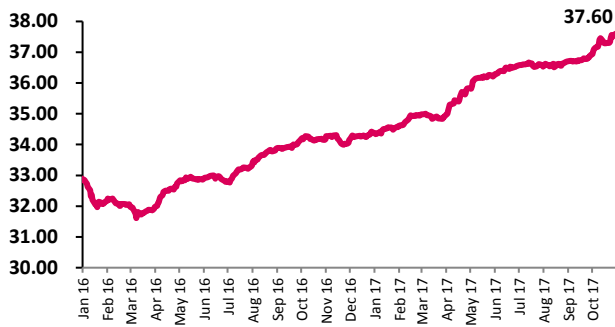

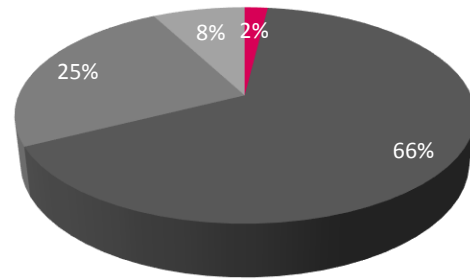
Your fund performance: Balanced fund

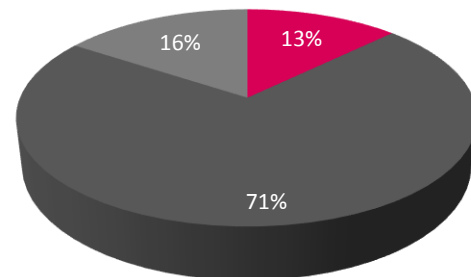

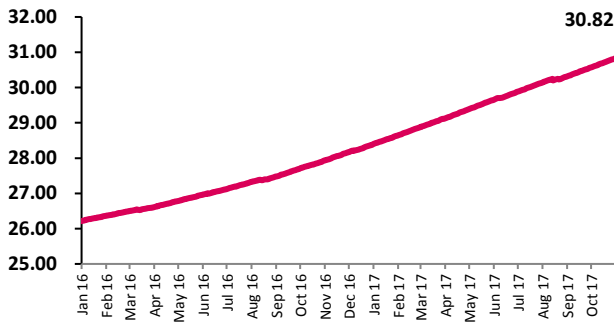

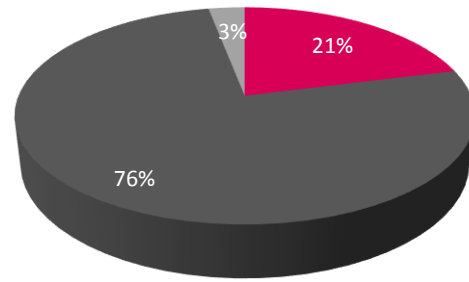
Your fund performance: Secure fund

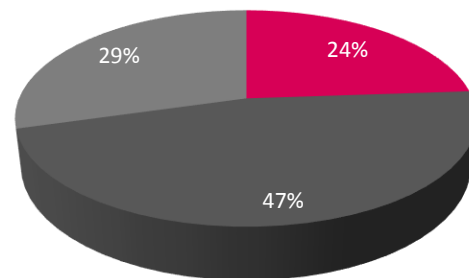

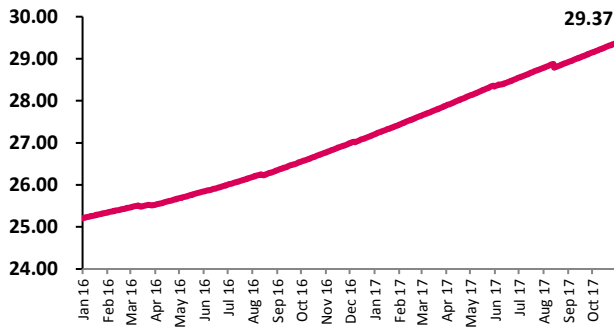

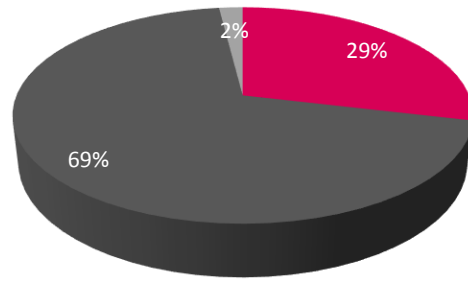

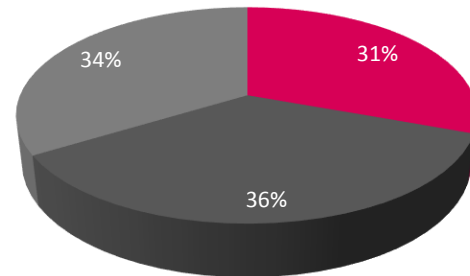

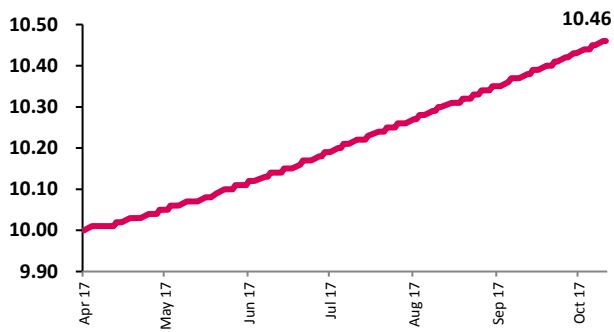

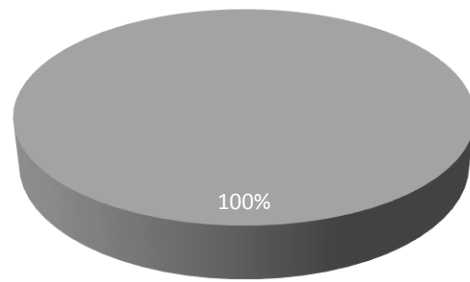
Your fund performance: Stable Money Market fund

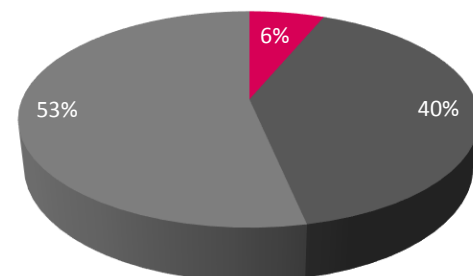

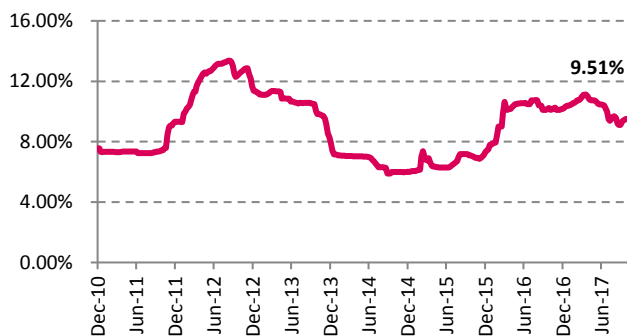

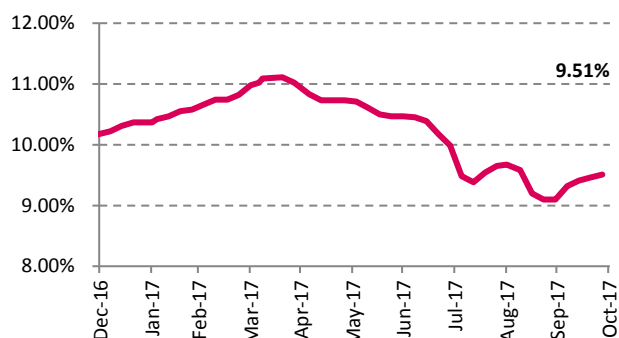
We use the 364 day T- Bill as an indicator of how interest rates move

364-day T-bill: Since 01 Jan 2017

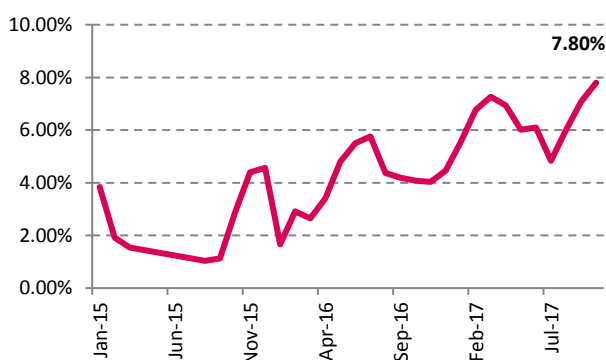

Major events during the month

- Central Bank raised LKR 84 billion by issuing treasury bills and LKR 25 billion by issuing treasury bonds.
- Central Bank policy rates play a key role in determining the direction and level of market interest rates. The Central Bank maintained policy rates unchanged during the month, a reflection of its intent.
- Short term interest rates were volatile over the month. For example the benchmark 364-day Treasury bill rate increased to 9.51% by end of the month against the previous month end rate of 9.10%.

Inflation: Since 01 Jan 2015

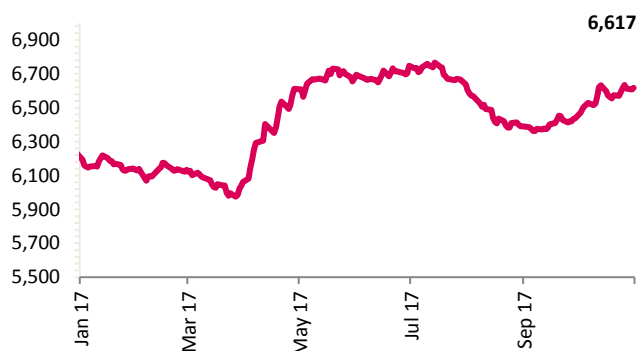

Highlights of the month

- The equity market performance marginally improved in Oct 2017 amidst foreign inflows to blue-chip companies.
- The ASPI increased by 6.2% over the period 01 Jan 2017 to 31 Oct 2017.
- Foreign investors bought LKR 2.0 billion on a net basis in Oct 2017, resulting in a net inflow of LKR 19.5 billion during the year to date 2017.

Fund manager's outlook



Fixed income outlook

- Treasury bill rates increased for the month of October with the benchmark 364 day Treasury bill rate increasing by 41 basis points. However, longer term bond rates did not see the same levels of increase in yield due to foreign buying in LKR denominated debt.
- Inflation has risen to 7.8% due to supply disruptions from adverse weather conditions prevalent in 2017.
- We also note bunching of debt repayments in the first half of 2018 may add pressure on rates although focus is expected to shift to elections in January.

Equity outlook

- ASPI performance for the month of October 2017 stood at 2.78%. The equity based linked funds outperformed the index in the month of October due to the portfolio's being over-weighted to the banking sector which had a healthy rally during the month.
- Foreigners continued to buy the more liquid blue chip counters and net foreign buying for the month stood at LKR 1.9 billion.
- We expect investors to remain in the sidelines ahead of the budget proposals for 2018 expected to be presented to parliament on the 09 Nov 2017.
- Despite recent macro tightening measures expected to slow earnings in the next few quarters, we believe that markets offer bargain opportunities to be capitalized.

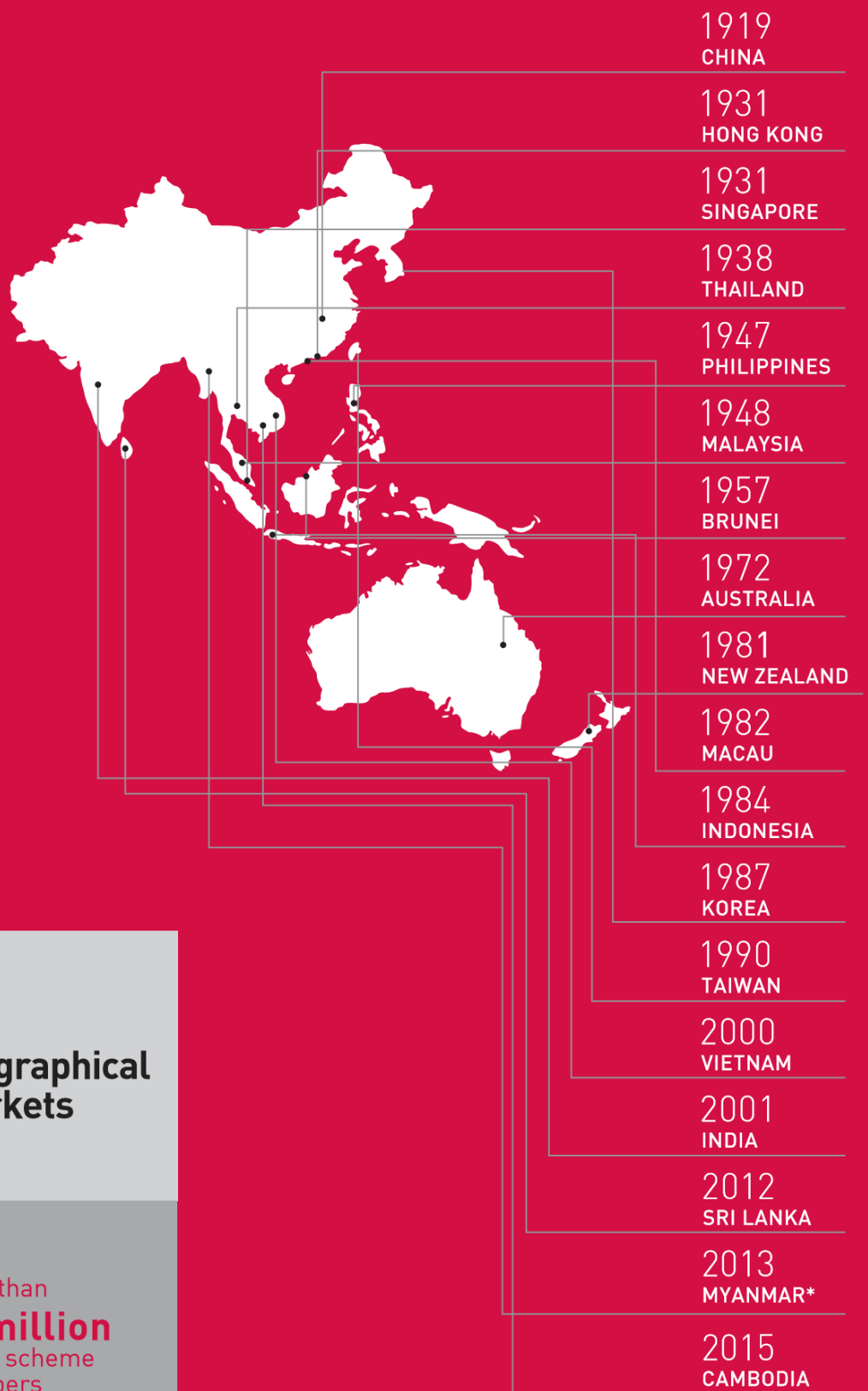
